The purpose of the George T. Welch scholarship is to give financial assistance to students who meet specific standards of academic achievement, character, or professionalism and require financial support to attend college. The Welch scholarship will pay a maximum annual amount of \$4,000.

A primary factor in measuring a student's financial need is the parent or guardian's ability to contribute toward expenses. For this reason, we ask applicants to submit a copy of their parent or guardians IRS 1040 for the previous year. Any information we receive will be held strictly confidential by Baker Boyer National Bank.

We urge you and your parents/guardians to read, thoroughly, the General Requirements sheet attached. When the Wealth Management & Trust Department receives an application, it is assumed that you have read and will accept these requirements.

Instructions to the applicant: (Please use as a checklist - **Incomplete applications are not processed.**)

1. All applications must be received by the Trust Department on or before **May 1st**. You will be notified of the Committee decision, in writing, by June 15th.
2. May 1st is the deadline to submit the FAFSA Student Aid Report (SAR) and IRS 1040. A complete copy of your parents or guardians IRS 1040 for the previous year must be submitted to Baker Boyer Wealth Management & Trust (include all pages).
3. A new application form needs to be completed whether you are a first-time applicant or are reapplying. No applications can be considered without the FAFSA SAR and IRS 1040. Exceptions may be granted if information is delayed due to circumstances beyond the applicant's control.
4. Complete the Letter of Application and the Statement of Estimated Expenses Resources. Then mail them to Baker Boyer Bank Wealth Management & Trust, Attention Marco Contreras, P.O. Box 1796, Walla Walla, WA 99362.
5. Request an official copy of your most recent high school or college transcript (through the first semester of the current school year) be mailed to Baker Boyer Bank Wealth Management & Trust, Attention Marco Contreras, P.O. Box 1796, Walla Walla, WA 99362.
6. Please **DO NOT** send any other information, e.g., letters of recommendation, list of honors or activities.
